Subject: COVID-19. Reporting requirements / Art. 30

of Law 21 of 2017

## Dear General Manager:

We refer to the Circular SBP-DR-FID-0087-2020 dated March 23, 2020 by means of which we informed trust companies of the temporary suspension of reporting requirements requested through Circulars FID-2004, SBP-GSF-0066-2012, SBP-GSF-0102-2012, SBP-GSF-0091-2013, SBP-GSF-0059-2014, SBP-GSF-0074-2017, and SBP-DR-FID-0033-2020, as an exceptional measure against the current situation of the COVID-19 effects.

In view of the foregoing, we inform you that the Superintendency of Banks has considered rescinding the aforementioned Circular SBP-DR-FID-0087-2020, therefore, the trust entities are notified of the reactivation of the submittal of the reporting requirements listed below:

- AF02 (Securities and Bonds)
- AF03 (Trust Company Information)
- AF04 (Deposits)
- AF05 (Loans)
- AF06 (Other assets)
- AF07 (Titles)
- AF08 (Liabilities)
- SB-UF-01 form

The information required for atoms AF02, AF04, AF05, AF06, AF07, AF08 and SB-UF-01 form must be submitted to the Superintendency containing the information of the first three quarters of 2020, according to the following timeline:

The information required for atom AF03 (Trust Company Information) must be submitted to the Superintendency containing the information from March to September 2020, according to the following timeline:

As of October 2020, trust companies must continue submitting to the Superintendency the information on the atoms for 2020, in accordance with the parameters established in the circulars requiring so.
