- 1. - 2. That, as a result of the above acquisition and by virtue of a Shareholders Agreement entered into by and between LSF-KEB HOLDINGS SCA and THE EXPORT-IMPORT BANK OF KOREA, HSBC ASIA PACIFIC HOLDINGS (UK) LIMITED may also acquire the 6.25% of the issued and outstanding capital stock that THE EXPORT-IMPORT BANK OF KOREA holds in KOREA EXCHANGE BANK, LTD.;

That **HSBC ASIA PACIFIC HOLDINGS** (**UK**) **LIMITED** is a corporation established and existing according to the laws of the United Kingdom, registered as company number 1113112 in the Corporations Record of England and Wales under The Companies Act of 1985, and is an indirect subsidiary of **HSBC HOLDINGS PLC**;
- 4. That **LSF-KEB HOLDINGS SCA** is a corporation established and existing according to the laws of Belgium and the owner of 51.02% of the issued and outstanding shares of **KOREA EXCHANGE BANK, LTD**;
- 5. That **KOREA EXCHANGE BANK, LTD.** is a corporation established and existing according to the laws of the Republic of Korea, registered as a foreign corporation as of 1 July 1971, in Microjacket 6860, Roll 270, Image 280 of the Microfilm (Mercantile) Section of the Public Registry of Panama, and holds a General License granted by National Banking Commission Resolution 17-80 dated 8 July 1980;
