- 1. That **HSBC BANK** (**PANAMA**), **S.A.** and **GRUPO BANISTMO**, **S.A.** have submitted a request for authorization to carry out a merger by absorption in which **HSBC BANK** (**PANAMA**), **S.A.** would be the surviving company;
- 2. That **HSBC BANK** (**PANAMA**), **S.A.** is a corporation established according to the laws of the Republic of Panama, registered in Microjacket 456744, Number 633197 of the Microfilms (Mercantile) Section of the Public Registry of Panama and authorized to engage in the banking business within or from Panama under a General License;
- 3. That **GRUPO BANISTMO**, **S.A.** is a corporation established according to the laws of the Republic of Panama and registered in Microjacket 490605, Number 788580 of the Microfilms (Mercantile) Section of the Public Registry of Panama;
- 4. That **GRUPO BANISTMO**, **S.A.** is the major shareholder of **PRIMER BANCO DEL ISTMO**, **S.A.**, a corporation established according to the laws of the Republic of Panama, registered in Microjacket 124625, Roll 12567, Image 0031 of the Microfilms (Mercantile) Section of the Public Registry of Panama and authorized to engage in the banking business within and from Panama under a General License;

That as a result of the merger being requested, HSBC BANK (PANAMA), S.A. will be the major shareholder of PRIMER BANCO DEL ISTMO, S.A. and of INVERSIONES FINANCIERA BANCOSAL, S.A., the holding company for GRUPO BANISTMO, S.A.'s banking operations in El Salvador, and of BANISTMO CAPITAL MARKETS GROUP, INC., a corporation established according to the laws of the Republic of Panama, registered in Microjacket 152793, Volume 172, Image 0012 of the Microfilms (Mercantile) Section of the Public Registry of Panama and possessing a trust license to engage in the trust business within or from the Republic of Panama;
