- 1. That THE BANK OF NOVA SCOTIA and BANCO COLPATRIA MULTIBANCA COLPATRIA, S.A. have applied for authorization to transfer 51% of the shares of BANCO COLPATRIA MULTIBANCA COLPATRIA, S.A. to THE BANK OF NOVA SCOTIA.
- 2. That **THE BANK OF NOVA SCOTIA** is a bank duly authorized to engage in the Banking Business under a General Banking License granted by the Superintendency of Banks.
- 3. That **BANCO COLPATRIA MULTIBANCA COLPATRIA**, **S.A.** is a bank authorized, under an International Banking License granted by the Superintendency of Banks, to manage, from an office established in Panama, transactions to be concluded, consummated or have effect abroad.
