ANNOUNCES:

- 1. That BANCOLOMBIA, S.A., a corporation established and existing according to the laws of the Republic of Colombia, and HSBC LATIN AMERICA HOLDINGS (UK) **LIMITED**, a corporation established and existing according to the laws of England and Wales, as buyer and seller, respectively, have jointly submitted a request through their resident agents for authorization to change the direct control of HSBC BANK (PANAMÁ), S.A.
- That HSBC LATIN AMERICA HOLDINGS (UK) LIMITED is the sole owner of all 2. common shares and 1.325.780 preferential shares, equivalent to approximately 90.1% of the preferred shares, of HSBC BANK (PANAMÁ), S.A.
- That **HSBC BANK** (**PANAMÁ**), **S.A.** is a corporation established pursuant to the laws 3. of the Republic of Panama and authorized to engage in the banking business in and from the Republic of Panama under a General Banking License granted by the Superintendency of Banks.
- That pursuant to the request and the Share Purchase Agreement entered into by the 4. parties, HSBC LATIN AMERICA HOLDINGS (UK) LIMITED and BANCOLOMBIA, S.A., the transaction involves BANCOLOMBIA, S.A., as buyer, acquiring directly 100% of the shares of HSBC BANK (PANAMÁ), S.A. and acquiring indirectly the subsidiaries owned by HSBC BANK (PANAMÁ), S.A., except for those related to operations within the Republic of Colombia.
