## **Republic of Panama Superintendency of Banks**

**RESOLUTION S.B.P. 083-2009** (dated 23 March 2009)

The Superintendent of Banks in use of his legal powers, and

## **CONSIDERING:**

That **HSBC BANK (PANAMÁ), S.A.** is a bank holding a General License granted by means of Resolution S.B.P. 187-2004 dated 2 July 2004;

That by means of Resolution 179-2007 dated 14 November 2007 the Superintendency authorized **HSBC BANK (PANAMÁ), S.A.** to open one (1) subsidiary in the Republic of Guatemala;

That afterwards, **HSBC BANK (PANAMÁ)**, **S.A.** requested the Superintendency authorize it to open one (1) branch office in the Republic of Guatemala instead of opening one (1) subsidiary in that country;

That pursuant to this request, after the relevant analysis and by means of Resolution S.B.P. 003-2009 dated 9 January 2009, the Superintendency authorized **HSBC BANK** (**PANAMÁ**), **S.A.** to open one (1) branch office in the Republic of Guatemala and rescinded Resolution S.B.P. 179-2007 dated 14 November 2007;

That through its resident agents, **HSBC BANK** (**PANAMÁ**), **S.A.** has submitted a new request to modify the authorization granted by means of Resolution S.B.P. 003-2009 dated 9 January 2009 and to authorize it to open a representative office in Guatemala City, Republic of Guatemala;

That the request was submitted by **HSBC BANK** (**PANAMÁ**), **S.A.** because the Bank has determined that in this way it could provide its banking products and services within the Republic of Guatemala more efficiently;

That pursuant to the provisions of Paragraph 1, Article 58 of the Banking Law and Rule 4-2002 dated 3 April 2002, opening establishments abroad must have the prior approval of the Superintendency; and

That after the relevant analysis the request submitted by HSBC BANK (PANAMÁ), S.A. raises no objections;

## **RESOLVES:**

**ARTICLE 1**: To authorize **HSBC BANK** (**PANAMÁ**), **S.A.** to open one (1) Representative Office in Guatemala City, Republic of Guatemala.

ARTICLE 2: To rescind Resolution S.B.P. 003-2009 dated 9 January 2009.
