CONSIDERING:

That **BANCO UNIVERSAL**, **S.A.** is a bank authorized to engage in the Banking Business in or from the Republic of Panama under a General Banking License granted by means or Resolution 24-94 dated 31 August 1994;

That **INMOBILIARIA UNIVERSAL 50, S.A.** is a corporation organized and existent according to the laws of the Republic of Panama, filed in the Public Registry under Microjacket 732824, Document 1956481;

That **BANCO UNIVERSAL**, **S.A.** and **INMOBILIARIA UNIVERSAL 50, S.A.** were authorized to effect a Merger by Absorption by means of Resolution S.B.P. 93-2012 dated 6 August 2012;

That based on Article 22 of Rule 1-2004, the Legal Agent for **BANCO UNIVERSAL**, **S.A.** has requested an extension in formalizing and filing the Merger by Absorption Agreement entered into by **BANCO UNIVERSAL**, **S.A.** and **INMOBILIARIA UNIVERSAL 50**, **S.A.** in the Public Registry;

That based on the justifications submitted by **BANCO UNIVERSAL**, **S.A.**, the Superintendency deems it prudent to grant the requested extension;

That pursuant to Article 22 of Rule 1-2004, the Superintendent is the approving authority for this type of request.

RESOLVES:

ARTICLE ONE: To grant BANCO UNIVERSAL, S.A. an additional three (3) months to formalize and file the Merger by Absorption Agreement entered into by and between BANCO UNIVERSAL, S.A. and INMOBILIARIA UNIVERSAL 50, S.A., previously authorized by Resolution S.B.P. 93-2012 dated 6 August 2012, in the Public Registry.

<u>ARTICLE TWO:</u> The extension granted for three (3) months starts at the expiration of the previous period.

<u>Legal Grounds:</u> Paragraph 6, Article 16 of the Banking Law and Article 22 of Rule 1-2004.
