CONSIDERING:

That **BALBOA BANK & TRUST, CORP.** is a bank holding a General Banking License granted by Resolution S.B. 33 dated 1 April 2005;

That **BANCO TRASATLÁNTICO**, **S.A.** is a bank holding a General Banking License granted by Resolution 5-79 dated 9 April 1979, issued by the National Banking Commission, today known as the Superintendency of Banks;

That pursuant to the merger by absorption between **BALBOA BANK & TRUST**, **CORP.** and **BANCO TRASATLÁNTICO**, **S.A.**, from which **BALBOA BANK & TRUST**, **CORP.** will be the surviving company, authorized by Resolution S.B.P. 154-2012 dated 6 December 2012, a series of actions will be taken to formalize the authorized merger;

That pursuant to Paragraph 2 of Article 58 of the Banking Law, the legal agents of the above banks have requested the Superintendency authorize the closing of the **BANCO TRASATLÁNTICO**, **S.A.** branch office located in Suite 3 of the Wonos Building on Block 19, 18th Street, Colon Free Zone, Province of Colon, as of 29 December 2012;

That by virtue of the closing of this **BANCO TRASATLÁNTICO**, **S.A.** branch office and after proper notification of its clients, the operations of this branch will be attended to by the branch office of **BALBOA BANK & TRUST, CORP.** located in Suite 3 on Block 5, Santa Isabel Avenue, Colon Free Zone, Province of Colon;

That pursuant to the provisions of Paragraph I, Subparagraph 2 of Article 16 of the Banking Law, the Superintendent of Banks is the approving authority for the closing of banking establishments, and;

That after the relevant analysis, the application submitted raises no objections.

RESOLVES:

To authorize **BANCO TRASATLÁNTICO**, **S.A.** to close its branch office located in Suite 3 of the Wonos Building on Block 19, 18th Street, Colon Free Zone, Province of Colon, as of 29 December 2012.

LEGAL GROUNDS: Article 58, Paragraph 2 and Article 16, Paragraph I, Subparagraph 2 of the Banking Law, Rule 1-2004
