## **RESOLUTION SBP-0036-2016**

(dated 1 February 2016)

#### THE SUPERINTENDENT OF BANKS,

in use of his legal powers, and

## **WHEREAS:**

**BANCO CITIBANK (PANAMÁ), S.A.** is a corporation established according to the laws of the Republic of Panama and authorized to engage in the banking business in and from the Republic of Panama under a General Banking License granted by means of Resolution SB 101-2002 dated 10 December 2002, issued by the Superintendency;

By means of Resolution SBP-0186-2015 dated 9 December 2015, the Superintendency authorized the transfer of 100% of the issued and outstanding shares of **BANCO CITIBANK (PANAMÁ)**, **S.A.** and its subsidiary to **SCOTIABANK CARIBBEAN HOLDINGS LTD.**, pursuant to the terms established in the proposed transaction;

By means of its resident agent, the Bank has requested authorization to change its corporate name to **SCOTIABANK (PANAMÁ)**, **S.A.** and to change its trade name to "SCOTIABANK TRANSFORMÁNDOSE";

Pursuant to the provisions of Rule 1-81 dated 17 February 1981, the Superintendency of Banks is the approving authority for the sole name that can be used as the corporate name of a Bank, as well as the use of acronyms, abbreviations or expressions of that corporate name as a trade name;

In accordance with the provisions of Subparagraph 17 of Article 16 of the Banking Law, the Superintendent of Banks is the approving authority for changes to Bank Articles of Incorporation;

After the relevant analysis, the request made raises no objections;

### **RESOLVES:**

ONE: To authorize BANCO CITIBANK (PANAMÁ), S.A. to change its corporate name to SCOTIABANK (PANAMÁ), S.A.

TWO: To authorize SCOTIABANK (PANAMÁ), S.A. to use the name SCOTIABANK TRANSFORMÁNDOSE as its trade name.

**THREE**: Pursuant to the provisions of Article 1 of Rule 1-81, **SCOTIABANK** (**PANAMÁ**), **S.A.** must ensure that its corporate name always accompanies the name **SCOTIABANK TRANSFORMÁNDOSE** whenever this is used.

**LEGAL GROUNDS:** Subparagraph 17, Paragraph I, Article 16 of the Banking Law and Rule 1-81 dated 17 February 1981.
