## RESOLUTION SBP-0050-2018 (dated 30 April 2018)

## THE ACTING SUPERINTENDENT OF BANKS

in use of his legal powers, and

#### WHEREAS:

**THE BANK OF NOVA SCOTIA** is a bank authorized to engage in the banking business in and from the Republic of Panama under a General License granted by the National Banking Commission, today known as the Superintendency of Banks, by means of Resolution 104-74 dated 24 September 1974;

Pursuant to Paragraph 2 of Article 58 of the Banking Law, **THE BANK OF NOVA SCOTIA** has requested the Superintendency authorize it to permanently close the banking establishments listed below, as of 31 May 2018:

- 1. Multiplaza branch office located on the third floor, "Banking Center" area of Multiplaza Pacific Mall, Punta Pacifica, Panama City;
- 2. El Dorado branch office located in Centro Comercial Camino de Cruces, El Dorado, township of Bethania, Panama City;
- 3. David branch office located on Via Interamericana, city of David, province of Chiriqui

According to Subparagraph 2, Paragraph I of Article 16 and Article 58 of the Banking Law, the Superintendent of Banks is the approving authority for closing banking establishments;

By means of Resolution SBP-JD-0024-2018 dated twenty-four (24) April, two thousand eighteen (2018), Mr. **GUSTAVO A. VILLA** was appointed Acting Superintendent from the twenty-sixth (26<sup>th</sup>) of April to the fourth (4<sup>th</sup>) of May, two thousand eighteen (2018), or until the Superintendent returns to his post;

After the relevant analyses, the request submitted by **THE BANK OF NOVA SCOTIA** raises no objections.

## **RESOLVES**:

To authorize **THE BANK OF NOVA SCOTIA** to close the following establishments:

- 1. Multiplaza branch office located on the third floor, "Banking Center" area of Multiplaza Pacific Mall, Punta Pacifica, Panama City;
- 2. El Dorado branch office located in Centro Comercial Camino de Cruces, El Dorado, township of Bethania, Panama City;
- 3. David branch office located on Via Interamericana, city of David, province of Chiriqui

**LEGAL GROUNDS**: Paragraph 2, Article 58 and Subparagraph 2, Paragraph I, Article 16 of the Banking Law.
