THE SUPERINTENDENT OF BANKS,  
In exercise of its legal powers, and

WHEREAS:

**PRIVAL BANK, S.A.** is a banking entity registered under the laws of the Republic of Panama, authorized to engage in the banking business under a General License granted by the Superintendency of Banks through Resolution S.B.P. No. 048-2010 dated February 25, 2010.

**PRIVAL BANK, S.A.**, in compliance with the provisions of Article 58 (2) of the Banking Law, requested authorization from this Superintendency to proceed with the relocation of the Calle 50 Branch, located at 50th Street and 71st Street, San Francisco judicial district (corregimiento), Province of Panama, to its new location at P.H. Santa María Business Park, Boulevard Santa María, Lot 72, Santa María Business District, Juan Díaz judicial district (corregimiento), Province of Panama. The closing date at the current location is January 13th and the opening date at the new location is January 15th, 2024.

In accordance with the provisions of Article 16, section (I) (2) of the Banking Law, it is the responsibility of the Superintendent of Banks to authorize the closure of banking establishments.

After the necessary analysis, the request submitted by **PRIVAL BANK, S.A.** presents no objections.

RESOLVES:

**SOLE ARTICLE:** To authorize **PRIVAL BANK, S.A.**, to proceed with the relocation of the Calle 50 Branch, located at 50th Street and 71st Street, San Francisco judicial district (corregimiento), Province of Panama, to its new location at P.H. Santa María Business Park, Boulevard Santa María, Lot 72, Santa María Business District, Juan Díaz judicial district (corregimiento), Province of Panama.

**LEGAL GROUNDS:** Article 58, (2) and Article 16, section (I) (2) of the Banking Law.
