RESOLUTION SBP-BAN-R-2025-00200April 4, 2025

THE SUPERINTENDENT OF BANKS,

In exercise of his legal powers, and

WHEREAS:

ATLAS BANK (PANAMÁ), S.A. – in Compulsory Liquidation holds a General Banking License granted by the Superintendency of Banks through Resolution SBP-0214-2016 of December 7, 2016.

Through Resolution SBP-BAN-R-2024-00093 of February 29, 2024, this Superintendency ordered, in accordance with the provisions of Articles 154 and subsequent articles of Chapter XVIII, the **COMPULSORY LIQUIDATION** of **ATLAS BANK (PANAMÁ), S.A.**

ATLAS BANK (PANAMÁ), S.A. – in Compulsory Liquidation, in compliance with numeral 2 of Article 58 of the Banking Law, has requested authorization from this Superintendency to carry out the relocation of the Liquidation Offices, currently located in Costa del Este, Avenida Boulevard, Financial Park Building, Panama City, to the 9th Floor of the Plaza Credicorp Bank Building, Calle 50, Panama City.

ATLAS BANK (PANAMÁ), S.A. – in Compulsory Liquidation has reported that, as part of the Compulsory Liquidation process, the sale of the bank's movable and immovable assets has been completed, making it necessary to relocate its offices while also seeking to reduce costs.

in accordance with numeral 2 of Article 58 of the Banking Law, the relocation of banking establishments requires the authorization of the Superintendency.

After the corresponding analysis, the relocation of ATLAS BANK (PANAMÁ), S.A. – in Compulsory Liquidation raises no objections.

RESOLVES:

<u>SOLE ARTICLE</u>: To authorize ATLAS BANK (PANAMÁ), S.A. – in Compulsory Liquidation to relocate its Liquidation Offices, currently located in Costa del Este, Avenida Boulevard, Financial Park Building, Panama City, to the 9th Floor of the Plaza Credicorp Bank Building, Calle 50, Panama City.

LEGAL GROUNDS: Article 58, numeral 2 and Article 16 (I.2) of the Banking Law.
