**WHEREAS:**

**BAC INTERNATIONAL BANK, INC.** is a banking entity authorized to engage in the banking business in or from the Republic of Panama under a General Banking License granted by the National Banking Commission (now the Superintendency of Banks) through Resolution No. 37-95 of October 3, 1995;

BAC INTERNATIONAL BANK, INC., pursuant to Article 58, paragraph 2, of the Banking Law, submitted a request to this Superintendency for authorization to relocate its Transístmica Branch, currently located at Transístmica, Simón Bolívar Avenue, 64th West Street, Panama City, Province of Panama, to its new premises located at Transístmica, Simón Bolívar Avenue, between 63rd and 64th West Streets, Panama City, Province of Panama, effective June 15, 2026;

Pursuant to Article 16, Section I, paragraph 2, and Article 58 of the Banking Law, the Superintendent of Banks is responsible for authorizing the closure or relocation of banking establishments;

Upon completion of the corresponding analysis, the request submitted by BAC INTERNATIONAL BANK, INC. raises no objections.

**RESOLVES:**

**SOLE ARTICLE:**

To authorize **BAC INTERNATIONAL BANK, INC.** to relocate its Transístmica Branch, currently located at Transístmica, Simón Bolívar Avenue, 64th West Street, Panama City, Panama Province, to its new premises located at Transístmica, Simón Bolívar Avenue, between 63rd and 64th West Streets, Panama City, Province of Panama.

**LEGAL BASIS:** Article 16, Section I, paragraph 2, and Article 58, paragraph 2, of the Banking Law.
