RESOLUTION SBP-JD-R-2023-00932 (14th February 2023)

THE BOARD OF DIRECTORS,

In exercise of its legal powers, and

WHEREAS:

Under Article One of Resolution ADM-R-2023-00913, dated 3rd February 2023, the Superintendent of Banks has delegated the authority and functions inherent to this position **solely and exclusively** to the Director of Administration or to the person who holds said position in his/her absence, for endorsing the following documents:

- a) Informe de excepción de no uso de la plataforma de cotización en línea, which is used when there is a single bidder in the market or there is no adequate substitute for the good to be acquired or service to be contracted,
- b) Informe de seguimiento de cotización en línea, which is used to notify the supplier whether the contract is approved or, alternatively, to inform the reasons that prevent the process from continuing,
- c) Letters sent to the General Directorate of Public Procurement to acquire goods/contract services other than those included in the virtual store catalog, when those posted do not meet the institution's required specifications or when the goods/services are less expensive than those included in the virtual store catalog, and
- d) Informe de rendición de cuentas de las compras por Convenio Marco, which must be submitted quarterly to the Office of the General Comptroller of the Republic. This report includes a summary of the procurements made from product catalogs exempted from the endorsement of said entity.

Delegating functions to the Director of Administration, or to the person who holds said position in his/her absence, is based on Article 16(II)(9) of the Banking Law, which vests this power to the Superintendent,

The need for prompt performance of duties and tasks entrusted by Law to the Superintendent requires immediate attention for the approval and signing of documents in the new procurement management platform; therefore, this delegation will expedite the processing of these procedures,

Under Article 16(II)(9) of the Banking Law, delegating functions to staff members of the Superintendency, subject to the decisions and guidelines of the Board of Directors, is among the duties of the Superintendent of Banks,

Considering these explanations, the Board of Directors

RESOLVES:

<u>TWO</u>: The Superintendent may temporarily or permanently recover authority or exercise it for specific cases if he/she deems it appropriate.
