Agreement No. 8-2003 (of October 16, 2003)

THE BOARD OF DIRECTORS

In exercise of its legal faculties, and

WHEREAS:

Pursuant to Number 7 of Article 16 of Decree Law No. 9 of February 26, 1998, the Board of Directors of the Superintendency of Banks is responsible for determining the interpretation and scope of legal and regulatory banking provisions in the administrative realm;

Pursuant to Number 1 of Article 20 of Decree Law No. 9 of February 26, 1998, the Superintendency of Banks is authorized to establish special services fees to be borned by Banks, in order to cover to its costs of operation;

That in the course of joint work sessions of this Superintendency, there became evident the convenience of defining the special services referred to in Number 1 of Article 20 of Decree Law No. 9 of 1998, as well as determining the costs or fees for said services provided by of the Superintendency of Banks.

AGREES:

<u>Article 1</u>: **SPECIAL SERVICE.** Special service is that specific service provided the Superintendency of Banks, upon request and in favor of a Bank, which costs and expenses are to be borne by the Bank.

<u>Article 2</u>: FEES FOR SPECIAL SERVICES. The following fees are established to cover expenses incurred by the Superintendency in the issuance, investigation and analysis of the documentation listed below:

- Application for General License or International License, FIVE THOUSAND BALBOAS (B/.5,000.000); and application for a Representation License, TWO THOUSAND FIVE HUNDRED BALBOAS (B/.2,500.00).
- 2. Application for Banking License change, **ONE THOUSAND BALBOAS** (B/.1,000.00).
- 3. Application for merger and consolidation of Banks or Economic Groups of which Banks are a member, **FIVE THOUSAND BALBOAS (B/.5,000.00)**.
- 4. Request for acquisition or transfer of shares of Banks or Economic Groups of which Banks are a member, **FIVE THOUSAND BALBOAS (B/.5,000.00)**.
- 5. Request for changes to articles of incorporation, **ONE HUNDRED AND FIFTY BALBOAS (B/.150.00)**.
- 6. Request for issuance of Banking License Certifications, **THIRTY BALBOAS** (B/.30.00).
- 7. Request for copies of documents maintained in the Superintendency, not classified as confidential or of restricted access, **TWENTY FIVE CENTS OF BALBOA (B/.0.25)** per photocopy, or **FIFTY CENTS OF BALBOA (B/.0.50)** per photocopy requiring immediate delivery.

<u>Article 3</u>: TIMING AND METHOD OF PAYMENT. All payments shall be made in full upon submission of the pertinent request. Payments relating to items 1 through 5 of the foregoing Article, may only be made through certified checks, Banking Check or Banking Transfer. In the case of numbers 6 and 7, payments may be made in cash.

NOTE: Payments for the aforementioned requests are not reimbursable.

Article 4: EFFECT. This agreement shall become effective upon its promulgation.
