RESOLUTION SBP-FID-0015-2019
(dated 5 August 2019)

THE ACTING SUPERINTENDENT OF BANKS
in use of his legal powers, and

WHEREAS:

ARAMO FIDUCIARY SERVICES, INC. is a corporation established and existing according to the Laws of the Republic of Panama, authorized to engage in the trust business in and from the Republic of Panama under a Trust License granted by the Superintendency of Banks by means of Resolution FID 5-2010 dated 1 July 2010;

By means of Resolution SBP-FID-0017-2018 dated 21 June 2018, the Superintendency authorized the commencement of the Voluntary Liquidation process and cessation of operations of **ARAMO FIDUCIARY SERVICES, INC.** under that trust license, in accordance with the Liquidation Plan submitted;

ARAMO FIDUCIARY SERVICES, INC. has formally communicated the conclusion of the Voluntary Liquidation process;

The Superintendency has verified the conclusion of the Voluntary Liquidation process in accordance with the Liquidation Plan submitted;

Pursuant to the provisions of Article 55 of Law 21 dated 10 May 2017 and with the Liquidation process concluded, the Superintendent is authorized to cancel the respective Trust License;

By means of Resolution SBP-JD-0070-2019 dated twenty-three (23) July 2019, Mr. **GUSTAVO ADOLFO VILLA** was appointed Acting Superintendent from thirty-one (31) July to the five (5) August 26, two thousand nineteen (2019) or until the Superintendent returns to his post.

Pursuant to the provisions of paragraph 6, Article 6 of Law 21 dated 10 May 2017, the Superintendent is the approving authority for requests such as this and

RESOLVES:

ONE: To rescind Resolution FID 5-2010 dated 1 July 2010, issued by the Superintendency of Banks, by means of which a Trust License was granted to **ARAMO FIDUCIARY SERVICES, INC.**, and to cancel that Trust License.

TWO: To order the Public Registry to make a marginal notation of the cancellation of the Trust License granted to **ARAMO FIDUCIARY SERVICES, INC.**, a corporation filed on Page 703021 (S) in the Public Registry of Panama, as provided in Article 55 of Law 21 dated 10 May 2017.

LEGAL GROUNDS: Article 47 and following articles of Law 21 of 2017 dated 10 May 2017, which amended Law 1 dated 5 January 1984.
